It is rare to find a true Renaissance man anymore, but that's just that you get with Ben Utecht. Ben has always chased his dreams, finding his way from a small river town in Minnesota to a Super Bowl championship field. Whether it was becoming a world champion in football, singing with major symphonies, serenading Muhammad Ali on his 70th birthday, or stepping into a national advocacy role, Ben has found success in many realms. He honed his already keen public speaking skills at the University of Minnesota, where he graduated with a degree in communications and even started a master's degree in sports management before being swept up into the NFL.

Ben has established himself as a prominent national

leadership and motivational speaker for corporations, conventions, and non-profit events. Both of his programs, The Champion's Way and The MVP Program , stem from lessons he learned in the locker room with Hall of Fame coach Tony Dungy and in the huddle with future Hall-of-Famer Peyton Manning. The Champion's Way spotlights and breaks down "The 4 Ls" of leadership: listening, learning, language, and love. The MVP Program comes from Ben's experience with concussions. It inspires audiences to truly care about their minds and to discover how integral memory is to identity. Both programs illuminate dynamic ways to succeed in business and life.

"I believe, as a speaker, that vulnerability equals connectivity. This is why I approach my keynote presentations with a mission of bringing you on an emotional journey through my life, into a hall-of-fame huddle, and onto a field of high-impact lessons. All our lives tell a story, and this is how I tell mine!"

As an influential advocate for brain health, Ben served as the national spokesperson for the American Academy of Neurology and currently sits on the prestigious board of the American Brain Foundation. Ben was given the AAN's most esteemed honor, the Public Leadership in Neurology Award, in 2014. Also at that time, Ben released a music video for his song "You Will Always Be My Girls," written as a love letter to his wife and daughters with the goal of emotionally connecting people to the importance of their memories. The video has impacted the lives of many, garnering over 1.3 million YouTube views to date.

Ben can now add "author" to his resume, with the release of his new book Counting the Days While My Mind Slips Away, published by Simon & Schuster. The book is the first memoir from a former NFL player who left the game as a result of concussions. It takes the reader on a heart-felt journey through the ups and downs of Ben's life with faith, family, and football. Ben has a message of hope that has reached a nation-wide audience, inspiring people to value every moment to its fullest.

# **JERRY OLSZEWSKI**

Jerry Olszewski enters his 12th season as the Augustana head football coach in 2024 as a three-time NSIC Coach of the Year. Entering his 17th season overall as a head coach, Coach Olszewski owns a career record of 106-59 while owning a 74-41 record in 10 completed seasons at Augustana.

He was named the 21st head coach in school history on Dec. 12, 2012, after five seasons as the head coach at St. Olaf in Northfield, Minnesota.

Olszewski began his tenure at Augustana in 2013 with a 41-28 win over MSU Moorhead in the season opener at Kirkeby-Over Stadium. Augustana posted a 4-2 record in home games during Olszewski's first season while allowing just 14.2 points per game at KO Stadium.

Before his appointment at St. Olaf, Olszewski was the defensive coordinator at the University of Wisconsin-Stevens Point for two seasons (2006-2008). He served two terms on the staff at Minnesota State (1993-1997 and 1999-2002).

He was with the Green Bay Bombers of the Indoor Football League as the offensive coordinator and special teams coordinator for one season (1998-99) and served one year as a defensive line coach at California Lutheran University (1997-98).

Away from coaching, Olszewski was the athletic director and dean of students for the Little Chute (Wisconsin) School District (1998-99) and chief executive officer of the Mankato Family YMCA (2002-2006).

Olszewski earned his bachelor's degree at Wisconsin-Stevens Point (1993) and a master's degree from Minnesota State-Mankato (1995). He earned All-Wisconsin State University Conference honors as a defensive back at Stevens Point and led the league in interceptions (1990).

An active member of the Fellowship of Christian Athletes for more than 20 years, Olszewski's community service also includes Special Olympics, YMCA volunteer, church youth leader, MS Walk coordinator and school district volunteer.

He and his wife, Deana, are the parents of one son Jett, and two daughters, Jersey and J.J.



# **ERIC HENDERSON**

Eric Henderson was promoted to head coach of Jackrabbit men's basketball March 27, 2019 and enters his sixth season at the helm of the program in 2024-25. He previously spent three years as an assistant at South Dakota State, rising to associate head coach for the 2018-19 campaign.

Henderson has posted a 109-48 overall record and a 65-15 mark in Summit League in his previous five years as head coach. Henderson's squads having never finished worse than second in The Summit League standings, while they have won at least a share of the Summit League regular season title in four seasons and won two conference tournament titles en route to a pair of NCAA Tournament appearances. Henderson's winning percentage at SDSU (.694) is the highest among all-time Jackrabbit coaches with at least 20 victories.

Henderson's first season in 2019-20 as a collegiate head coach was a historic one as he was named The Summit League Coach of the Year while guiding the Jackrabbits to a 22-10 record and share of their third-straight Summit League regular season title. Henderson coached three all-league performers, including the league's Player (Douglas Wilson) and Freshman (Noah Freidel) of the Year. SDSU went 16-0 at home in 2019-20 and posted a 13-3 record in league play.

The 22nd head coach in Jackrabbit basketball history, Henderson began his coaching career as an assistant at Wayne State (Neb.) from 2001-03 and returned to the collegiate ranks as an assistant at North Dakota State from 2014-16 after coaching in the prep ranks in Wisconsin.

A 2000 graduate of Wayne State (Neb.), Henderson began his collegiate coaching career at his alma mater from 2001-03 as an assistant coach. After coaching girls' basketball at Wayne Community School for two seasons, he moved on to Iowa State, where he was the graduate manager for the Cyclones' men's basketball team from 2006-08 and a learning specialist for the 2008-09 season. He returned to coaching in the prep ranks at Burlington Catholic Central High School in Burlington, Wisconsin, from 2009-14, while also serving stints as principal and athletic director.

He and his wife, Alicia, live in Brookings, South Dakota with their four children, sons Kooper, Kort and Kyler, and daughter McKinley.
